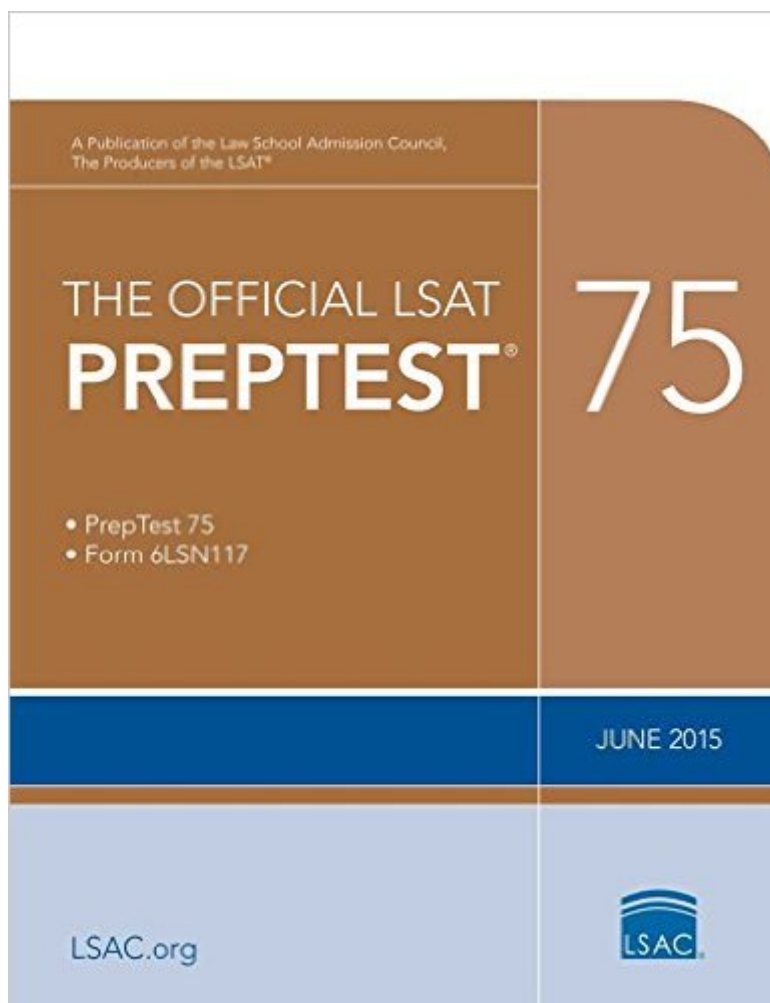

This is the newest LSAT preptest, as of the time of this review (August 2015). The LSAT changes with time. Get the newest test; it's the best indicator of what future tests will look like. Considering how important the LSAT is to your odds of admission, this book is well worth the price. You should also get the following books: LSAT 74, LSAT 73, LSAT 72, LSATs 62-71, LSATs 52-61. Total cost is around \$60-\$70. There's no better investment you could make towards a better LSAT score. For more practice, get pretests 29-38. Note that only pretests 66-76 have two pages for logic games diagrams. Use only the second page for your diagrams. It is surprisingly easy to lose your train of thought when you have to move your eyes across multiple pages. This test also has a comparative reading passage. Every test from 52 onwards has comparative reading. Graeme Blake, Moderator of Reddit's LSAT forum, says: LSAT pretests don't come with explanations.
